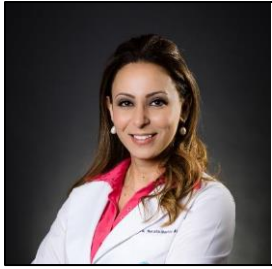

Dr. Susana Zabalo de Jerabek

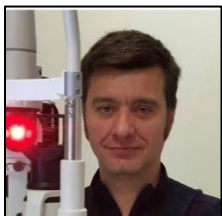

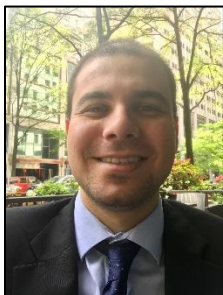
